Only Heather Brown will perform pet care. In the event of an emergency, *Crazy Mutt / Heather Brown* will obtain the services of another qualified individual to cover in her absence. In the event of an emergency and the need to obtain alternative care, I will be notified prior to obtaining the services of said alternative.

_____ *Crazy Mutt / Heather Brown* agrees to provide the services stated in this agreement in a reliable, caring and trustworthy manner. In consideration of these services and as an express condition thereof, I, the client, expressly waive and relinquish any and all claims against *Crazy Mutt / Heather Brown*.

_____ I, the client, will be responsible for all medical expenses and damages resulting from an injury to the pet sitter, or other person(s), by the pet(s). I agree to indemnify and hold harmless *Crazy Mutt / Heather Brown* in the event of a claim by any person injured by the pet(s).

_____ It is expressly understood that *Crazy Mutt / Heather Brown* shall not be held responsible for any damage to client's property, or that of others, caused by client's pet(s) during the period in which they are in the care of *Crazy Mutt / Heather Brown*.
